1. Contestants must be female, never married and residents of Cooper County for at least 6 months or graduated from a Cooper County High School.
2. Contestants shall be citizens of the United States.
3. Contestants shall be not less than 17 or more than 22 years of age on September 1, 2021.
4. Contestants must be a high school graduate.
5. Entrants must be sponsored by a youth organization but need not be a member of said organization. (examples: 4-H Clubs, FFA, Church Youth Group or Youth Sunday School Class, Student Council, High School Band, Boy/Girl Scouts, YMCA, etc)
6. All entrants are required to compete in all areas of competition. Those areas of competition are interview, public speaking or talent competition, modeling, evening gown and impromptu questioning. Additional information will be posted as it becomes available.
7. \*\*\*Speech or talent cannot exceed 2 minutes in length. Contestants may call: Amber Carmichael 660-537-0728 or email at [carmichaela@outlook.com](mailto:carmichaela@outlook.com) with any questions. Speech can be any topic fitting for a family environment. Talent can be anything showing poise and fitting for a family environment.
8. The winner will be required to attend fair events, present prizes at fair events, promote future fairs and represent Cooper County at the 2021 Missouri State Fair.
9. Candidates must be able to comply with the official 2021 Missouri State Fair Rules and Regulations.
